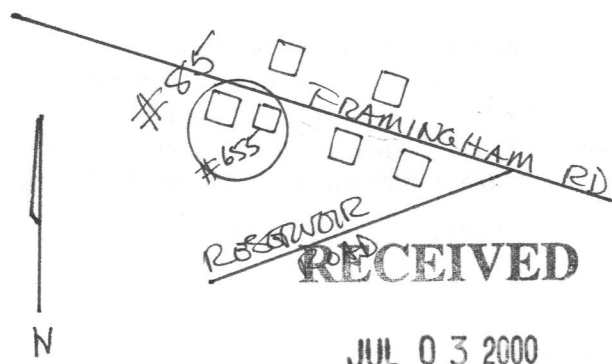

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

This two-story, cross-gabled house stands with its main roof ridge parallel to the street, with its entry in the north, cross-gabled portion under a corner porch sheltered by the extended overhang of the north roof slope. Behind the entry is a shallow, flat-roofed north ell; beyond that the cross-gabled portion continues to the rear, where a low addition connects to a long, gable-roofed 1 1/2-story twentieth-century wing on a concrete block foundation. A one-car garage occupies the basement story of the wing.

Four bays of 2-over-2-sash windows with molded surrounds occupy the east, street side of the main house. The entry in the north end has a multi-light twentieth-century door; the corner of the roof overhanging the entry porch is supported on a turned post. The garage door in the north end of the wing is a mid-twentieth-century panel-and-glass overhead type.

Standing against the hillside just south of the house is a small gable-roofed former barn (#655) on a high foundation of fieldstone and rock-faced concrete block, which houses a two-car garage at the basement level. It is now a dwelling (114 Framingham Road), but retains its simple lines. The two overhead, panel-and-glass garage doors face the street in the lower story. All the windows in the building appear to be twentieth-century replacements, in 1-over-1 or 6/1-sash combinations. The two windows on the main south wall are surmounted by semi-circular wooden fans, added since 1971. A one-story, hip-roofed den extends to the south, on a fieldstone foundation, and a shed-roofed addition spans the west, rear side of the building.

Like several of its neighbors, this house is believed to have been moved from the Sudbury Reservoir area prior to the building of the Metropolitan Waterworks dam a short distance to the east in the mid-1890s, which inundated hundreds of acres of farmland in the northeast part of Southborough. According to local knowledge, it was built by farmer Peter Walker (see #83, 5 Cross Street, also Area Form V), for one of his six adult children, who were born between 1828 and 1849. The map of 1870 shows that by that time a house was already standing at this location. It belonged to **John Donahue**, a small farmer who had 5 3/4 acres, the house, a barn, woodshed, and two cows.

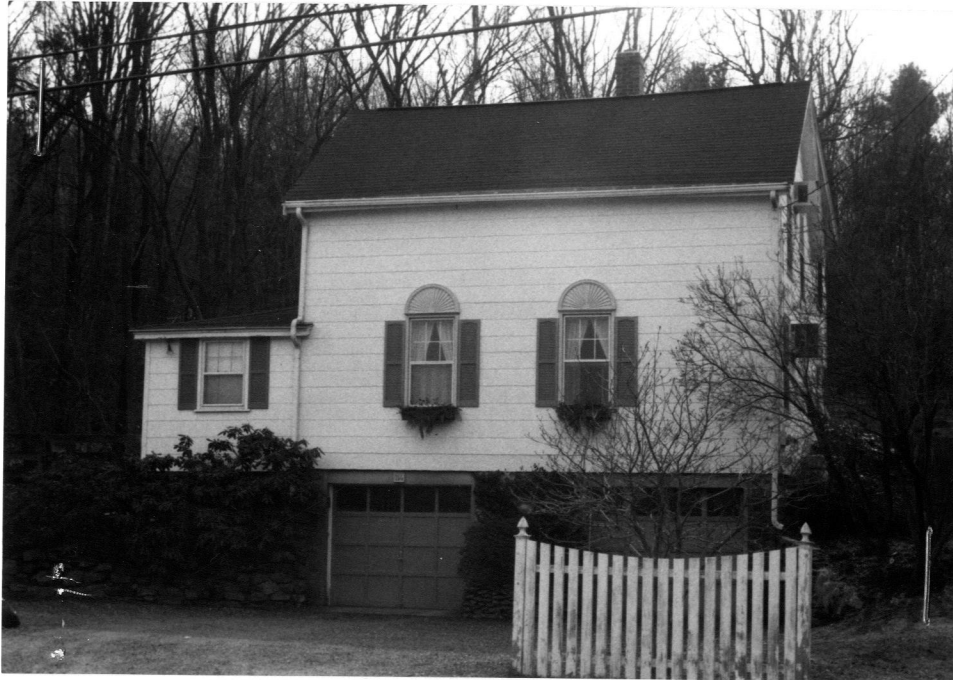
Around the time of the Civil War, Framingham Road was one of the areas of town where Irish immigrants were buying up older farms, and Mr. Donahue was apparently part of a succession of Irish-born owners who owned this property for many decades. By 1897, the owner was **William Colleary**, gardener for the Burnett family on Main Street and Deerfoot Road, who lived and raised chickens here. By his time, the property had been reduced to less than 1 1/2 acres. Mr. Colleary lived here through at least 1913. The house was later owned by the **Kelley** family.

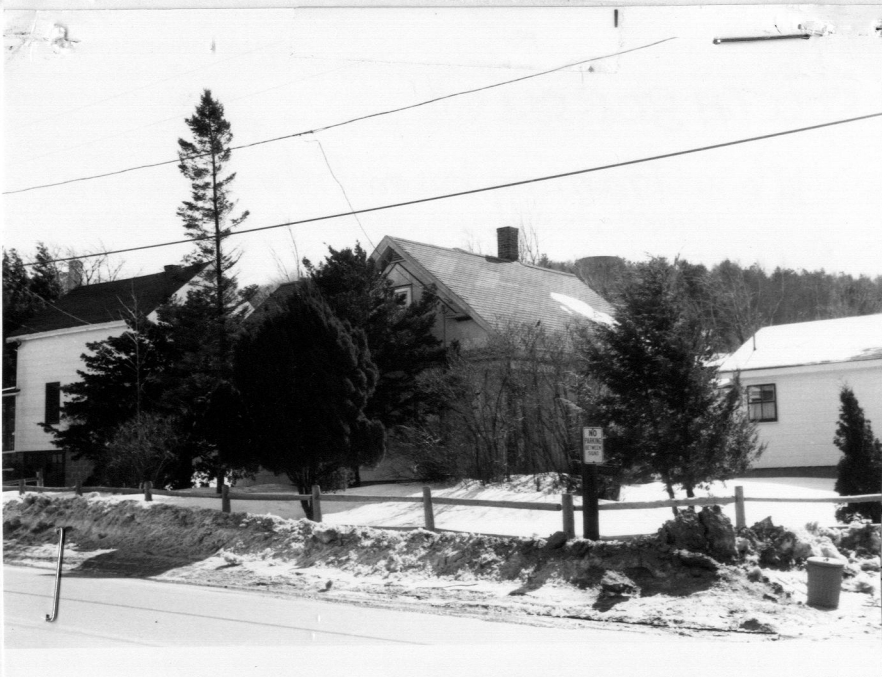

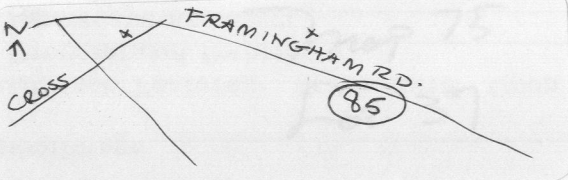
