

One of the most prominent dwellings in Southville, this ca. 1840 Greek Revival Style house is located on a lot that is approximately one-half of the mid-nineteenth century parcel. It is one of the larger lots within close proximity to the village center with former train depot and store, churches and former schools. The lot drops off to the east and south so that the house sits atop a small plateau that has a stone retaining wall on the east side. This stately house sits on a granite block foundation and has wood clapboard walls with wood trim. The tall two-story house displays a templar gable front carried by three monumental fluted Doric-like columns with no bases. The entablature, cornice and full pediment are plain and nicely proportioned and there is a single window in the gable peak. The sidehall entrance within the open porch has a later early twentieth century door with square light and horizontal applied molded panels, flanking full side lights and a simple frame with a slight or shallow pediment for the lintel. A full length six-over-six window is found to the left of the entrance and the two second-story windows also have six-over-six sash set in frames with slightly pointed lintels. The main house is two bays deep and windows are similar to those on the front. All windows have louvered wood shutters. The wide corner boards are made from several narrow flush vertical boards and have molded caps. On the west side there is a square leaded light stair hall window and a one-story side ell with an enclosed porch. A one and onehalf story rear ell extends behind the side ell and connects the small barn. All of this is shown on the 1887 Bailey Lithograph. The barn has a wide sliding door made of vertical tongue and groove boards with a hay door over the main entrance. In the peak is a six-over-six window and to the left of the door is a nine-light window. One chimney is located below the ridge on the west side. There is a square lattice well house (MHC #971) west of the dwelling. It has a hipped roof with a tall iron spire or finial. It has an early twentieth century Colonial Revival look to it.

The village of Southville was established with the coming of the Boston and Albany Railroad in the 1830s and the construction of a railroad depot near Parkerville and Southville Roads by 1840. By 1850 there were two substantial factories, one a boot and shoe manufactory and the other a cotton and wool mill. This is one of the grandest houses in size and architectural elaboration in Southville and Cordaville and probably was built ca. 1840. First known owner Thomas Boyd came from Marlborough with his brother Joseph who owned the elaborate house at 246 Parkerville Road. Annual reports in the early 1860s state that the Town paid residents to help build and maintain roads and schools. Thomas Boyd was paid in 1860 for the use of his plough and for 39 loads of gravel. The later owner was Elliot Claflin who in 1870 was assessed for a three and one-half acre farm, house, barn, four cows and two young horses. He also must have used other land for farming as he was assessed for 5 acres 80 rods of Lord's sprout land and for 2 1/2 acres of H. Newton's land, and by 1874 he also used 21 acres of Prentiss land. Although Claffin did not remain at this property in the 1890s, he or a son named Elliot Claflin lived in Southville and worked as a house painter into the early 1900s. In the 1890s the property of one acre and 120 rods was owned by Michael J. Powers 2<sup>nd</sup> who was assessed for the house, barn and a single cow and horse. Powers was a section boss on the Boston and Albany Railroad. By the 1910s Michael J. Powers 2<sup>nd</sup> (not to be confused with M. Powers the 1<sup>st</sup> who was a gardener and also lived in Southville) still worked as a section master for the railroad and had the same lot of land with house, barn and woodshed. In 1909 he was fifty years old. The 1971 survey reports Capen following Powers and then Joseph Blake (1920s).

The Thomas Boyd House, also known as the Elliot Claflin House, is eligible for listing on the National Register individually or as part of a Southville Historic District for its representation of an important example of a midnineteenth century Greek Revival house with fine monumental columns in the former manufacturing village of Southville. The property's architecture and historical association with the development of Southville are worthy of recognition and the complex retains integrity of location, setting, design, materials, workmanship, association, and feeling.
