

ARCHITECTURAL DESCRIPTION [ ] see continuation sheet

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

One of the best-preserved of Southborough's eighteenth-century Federal farmhouses, this 2 1/2-story, side-gabled building is a four- by two-bay "three-quarter house," with a large chimney placed slightly off-center at the roof ridge. A short two-story, cross-gabled rear wing overlaps the southeast rear corner of the house by one bay; its rear section continues south as a steeper-pitched, one-story ell. In front of the wing on the east is a screened one-story porch spanning the east end of the house. A small attached 1 1/2-story barn or carriage house, with a hay door in the upper part of its east gable end, extends to the rear of the wing.

The windows of the house, which have the proportions of 6-over-9's, now have 1-over-1 replacement sash; those on the facade have modern wooden louvered shutters. A few 6-over-6-sash remain on the rear wing. The facade entry has a door of six raised panels under a three-light transom. The surround, of a type commonly based on designs in builders' guides of the period, has flat, tapered pilasters, a two-part frieze, and a molded cornice. The house trim includes a molded, boxed cornice with returns, but no overhang at the gable ends.

East of the house, across a driveway, is a small two-story side-gabled, clapboarded barn (#635), built into the hillside, with a leanto bay along its rear, east side. A sliding vertical-board exterior wagon door is located on the west side, facing the house. Two bays of 6-over-6-sash windows occupy the north gable-end of this barn.

This house is part of a trio of Johnson family houses that were built on one of Southborough's earliest farms-dating back to land belonging to one of the founders of the town, William Johnson. It was built for Elisha Johnson, Jr., also called Captain Elisha Johnson, in about 1810 as a gift from his father, who lived across the road at 35 Lynbrook Rd. (See Form #8 for the earlier history of the property).

Elisha Johnson, Jr. (1783-1854) married Sophia Loomis of East Windsor, Connecticut in 1808. Of their nine children, several eventually settled nearby on farms of their own. The house was struck by lightning in August of 1819. While the family inside survived, the chimney and much of the kitchen had to be rebuilt. Referred to as Capt. Johnson, he received his military ranking in the local military company in the early nineteenth century. He was also a loyal member of the Congregational Church, and one of the founders of the local debating society, formally named the Southborough Franklin Institute, in 1828.

By 1850, Capt. Johnson's farm measured 66 acres, with ten more at another location. Of average production for this agricultural community, that year it produced 100 bushels of corn, thirty of oats, 80 of potatoes, and twenty tons of hay. Capt. Johnson also kept a half-dozen cows, which produced both milk and butter. Upon his death in 1854, the property was inherited his second son, **Dr. Henry F. Johnson**.

Henry Johnson, (b. 1813), graduated from the Berkshire Medical Institute in 1839. He spent some time in Paris in the mid-1840s, returning to Worcester in about 1850. He then lived and practiced medicine for a few years in Boston, but moved back to Southborough when his father died. He commuted to his Boston office until 1867, when he sold the farm, and relocated to Cambridge.

#### HISTORICAL SIGNIFICANCE, cont.

The buyer of the farm was Capt. Benjamin F. Pierce. He kept about ten cows, and had several outbuildings on the property. In about 1885, however, he sold the property back into the Johnson family-to Charles L. Johnson, a grandson of Elisha and Sophia (son of their eldest child, Nathan L. Johnson-see Area Form O, Wolf Pen Farm).

Charles Johnson carried the farm into the early part of the twentieth century. In the late 1890s he had a large herd of two dozen cows, four horses, and a flock of 125 fowl, which he kept in five hen houses. He also owned an ice house where he stored ice cut from the brook during the winter. In 1921 the house was acquired by **Joseph Wentworth**.

The well-preserved Capt. Elisha Johnson, Jr. House meets Criterion C of the National Register at the local level as one of the best-preserved examples in Southborough of an early-nineteenth-century Federal "three-quarter house".

The property is also significant under Criterion A for its connection with Capt. Elisha Johnson, a prominent member of the Johnson family, who for generations both dominated and developed hundreds of acres of Southborough's rural "west end" in the eighteenth and nineteenth centuries.

For all the above reasons, the property is also eligible as contributing to a potential historic district composed of a trio of Johnson family houses built on one of Southborough's earliest farms, now numbered 26, 35, and 49 Lynbrook Road.

The house retains integrity of location, design, materials, workmanship, setting, feeling, and association.
