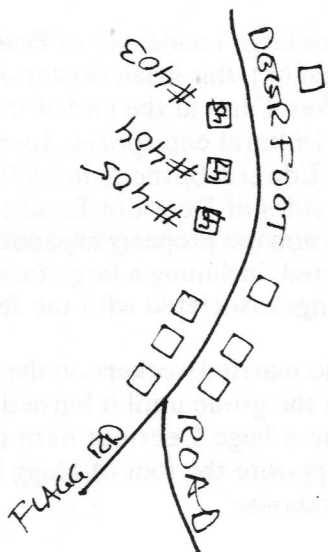

Describe architectural, structural and landscape features and evaluate in terms of other areas within the community.

Although the area around these ca. 1875 farm cottages is now developed with late-20th-century houses, and a large modern elementary school (the Neary School,) occupies a large tract across the road, this little cluster of buildings is still quite true to its late-nineteenth-century appearance. It consists of three small farm cottages situated close together at the curve of Deerfoot Road. Two of the houses, 45 and 47 Deerfoot Road, are nearly identical mansard cottages--low, square, each with a one-story, gable-roofed rear ell and a hip-roofed facade porch. The third, 49 Deerfoot Road, is a long 1 1/2-story gable-front, sidehall-entry cottage with a short, flat-roofed one-story rear ell.

In front of the houses, Deerfoot Road is lined with fieldstone walls and mature trees, including at least one large beech tree that may remain from the original period of Deerfoot Farm ownership.

Explain historical development of the area. Discuss how this area relates to the historical development of the community.

With the exception of buildings associated with the two large residences of Burnett family members at 84 Main Street and 16 Deerfoot Road (See Forms #21 and 68), this small cluster of houses is all that remains from the many structures that stood on the vast Deerfoot Farm at the end of the nineteenth century. The founder of this most successful of Southborough's agricultural enterprises, Joseph Burnett, passed on the management of the Deerfoot dairy farm to his son, Edward Burnett, in 1871. By that time it already covered nearly 500 acres, most of it situated on both sides of Deerfoot Road from Stony Brook south to Flagg Road. Under Edward Burnett both the business and the property expanded further. From the 1870s through the early 1890s many new buildings were erected, including a large farmhouse for the farmhands, a new cow barn, a cattle barn, and a variety of buildings associated with the farm's creamery.

Edward Burnett had these three cottages built to rent to married workers on the farm. A fourth one, gable-fronted like 49 Deerfoot, stood at the southern end of the group until it burned down in the middle of the twentieth century. The group was positioned opposite a huge Deerfoot barn (either the cowbarn or the mid-1890s cattle barn) off the east side of Deerfoot opposite the foot of Flagg Road. A short distance to the north was another barn and the big Deerfoot farmhouse.

Statement of Significance by Forbes/Schuler, Consultants

The criteria that are checked in the above sections must be justified here.

This cluster of 1870s farm cottages meets Criteria A and C of the National Register at the local level as a historic district or complex. The houses, built for married workers on Deerfoot Farm, fulfill Criterion A as an illustration of the development of this large, important commercial farm in the early years of its great expansion under the progressive management of Edward Burnett, and thus also illustrate one aspect of the agricultural development of Southborough in the latter part of the nineteenth century. For their well-preserved vernacular architecture, representing a typical approach to housing for management employees of a prosperous farm, the line of cottages also meets Criterion C.

The area retains integrity of location, design, setting, materials, workmanship, feeling, and association.
